OLD BUSINESS

1. Publicly-Funded Projects (Other) CPAC Public Art Initiative Final Designs

Kat Wright

a) Northwest CPAC Mural

- **a.** Staff shared a 3D perspective of the mural design supplied by the artist, David Nackashi. The final design is known as "Cookout" for the exterior of the Charles "Boobie" Clark Center.
- **b.** Pending today's vote to approve, Nackashi is aiming to start sometime in early September and anticipating completion by September 22nd.
- **c.** The mural will be more of a wrap as it will activate 5 of 12 panels of the circular building. Parks and Recreation will be activating the remaining panels in a solid color that will complement a color in the mural.
- **d.** Nackashi will be applying a non-sacrificial graffiti resistant coating to prevent graffiti and minimize UV exposure. Staff recommended that Parks also utilize the same coating as well.
- **e.** Staff asked the Committee to refer to the project's community engagement report to learn about the mural's imagery and colors that have a tie with the community.
- f. Staff reviewed the budget allocations and shared that they are anticipating a sign permit will need to be pulled and it will be the project's 10% contingency set aside that will address that cost if it is needed. The time it takes to process the permit may delay the start the mural.

b) Southwest CPAC Mural Wrap

- **a.** Staff shared a 3D perspective of the mural design supplied by the artist, David Nackashi. The final design is known as "Birdhouse" for the picnic shelter at Lane Wiley Park.
- **b.** Pending today's vote to approve, Nackashi is aiming to start this mural as soon as possible, likely before the NW CPAC Mural. Monday and anticipating completion by mid-September.
- **c.** The mural will wrap around three sides of the shelter, which can be seen from the Senior Center, the park and the basketball court.
- **d.** Parks and Recreation will be aiding the project by performing mold remediation and priming the shelter. A non-sacrificial graffiti resistant coating will be utilized to limit graffiti and UV exposure over time.



- **e.** The proposed budget in each Committee members folder is complete and in full-no permits are needed.
- **f.** Staff referred the Committee to the community engagement report to become familiar with the mural's premise.
