The Art Selection Panel reviewed Semi-Finalist Applicants which consisted of all applicants scoring 2.0 and above that also exhibit examples of, or the qualifications to create: an interactive work, engaging artworks for park users of any age, a focus on school age children in active play, and playful, colorful 3D sculptures that invite interaction with activities that relate to sport training. The following points were made by the group:

- The ASP felt that Solomon Bassoff exhibited interactive qualities that focused on nature's flora and fauna, most appropriate for the multi-functional aspect for users of Losco Park to be selected as this park's finalist.
- The ASP felt that Greg Mueller exhibited the interactive qualities that focused on sports and sports training, most appropriate for the athletic aspect for users of Chuck Rogers Park to be selected as this park's finalist.
- The ASP felt that Richard Herzog was the best alternative to both Losco and Chuck Rogers finalists. He exhibited the interactive qualities that focused on both nature's flora and fauna and sports and sports training.
- The ASP felt that Peter Hazel was the best alternative to the alternate in the event that the alternate could not accept the commission for Losco Park. He exhibited interactive qualities that focused on nature's flora and fauna.
- The ASP felt that Jill Pitko was the best alternative to the alternate in the event that the alternate could not accept the commission for Chuck Rogers Park. She exhibited interactive qualities that focused on sports and sports training.
